1	The total number of sections of the school shall be restricted to 36 as per the number of sections running during inspection. of which not more than 1/3rd sections may be used for senior secondary classes. Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and subject to availability of class rooms of greater than 500 ft dimension.

2	The school has made the temporary ramp at ground level and does not have toilets for CwSN. Thus, the school is required construct the ramp at ground level and separated toilets (for Girls /boys) on each floor with proper permanent signage, indicating the floor number are made as per norms of RPwD Act and board's guidelines (https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf).
3	The school is required to make the separate reading space in the library for its staff within 03 months and submit the compliance.
4	The school is required to construct the partition in boys urinals within 03 months and submit the compliance.
5	The school shall conduct training of its teachers with CoE Patna within 3 months and submit the compliance

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/-every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.
